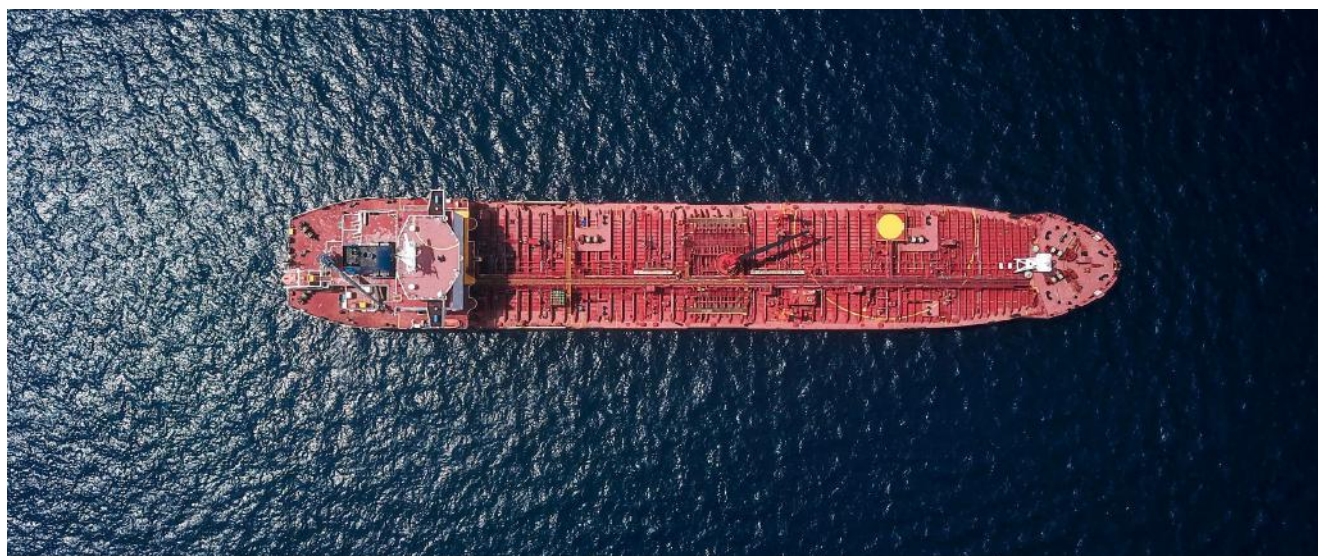

## PRE-PURCHASE SHIP INSPECTION

We at Jalship offer pre-purchase vessel condition assessment services at major ports around the world. Our global network of expert ship inspectors enables us to appoint the best inspector nearest to the inspection port without any overhead cost. We have delivered this service in over 75 countries. Our inspectors have Chief Engineer and Technical Superintendent backgrounds and conduct the most efficient yet detailed assessments of the vessel's condition. Our standard vessel pre-purchase inspections typically take 10-12 hours of visual examination onboard followed by a review of vessel performance records. However, if the vessel stays in the port for a shorter period, we try to accommodate such cases by appointing two inspectors. The JALSHIP maritime engineers are well-versed to interrogate the best inspection services that deliver a quality-driven outcome, and healthy ship working for years.



## PRE-VETTING INSPECTION

The purpose of these inspections is to successfully complete Cargo Major Inspections. Cargo Majors or Petroleum Terminals generally conduct an inspection of the 3rd party vessels against standards of safe vessel operation developed through inputs of various stakeholders in the industry. Based on the rating of the vessel's condition, these cargo majors permit the vessel to carry their cargoes or allow them to operate on their terminal. Commercially, it is very critical to have your vessels endorsed by cargo majors in order to increase the commercial engagement of the fleet.

Vetting Inspections are a snapshot evaluation of your operating procedures, implementation, and condition of the vessel and her equipment. It is crucial to keep your vessels prepared all the time for vetting to maximize commercial opportunities.

We have specially designed ship inspections based on the SIRE program and RightShip for Oil & Chemical Tankers or Bulk Carriers to evaluate the preparedness of the vessel for the upcoming vetting inspections. This service usually involves a 2 -day visit to the vessel, preferably during cargo discharging. We provide truly independent advice on potential gaps, risks, and how to mitigate them.

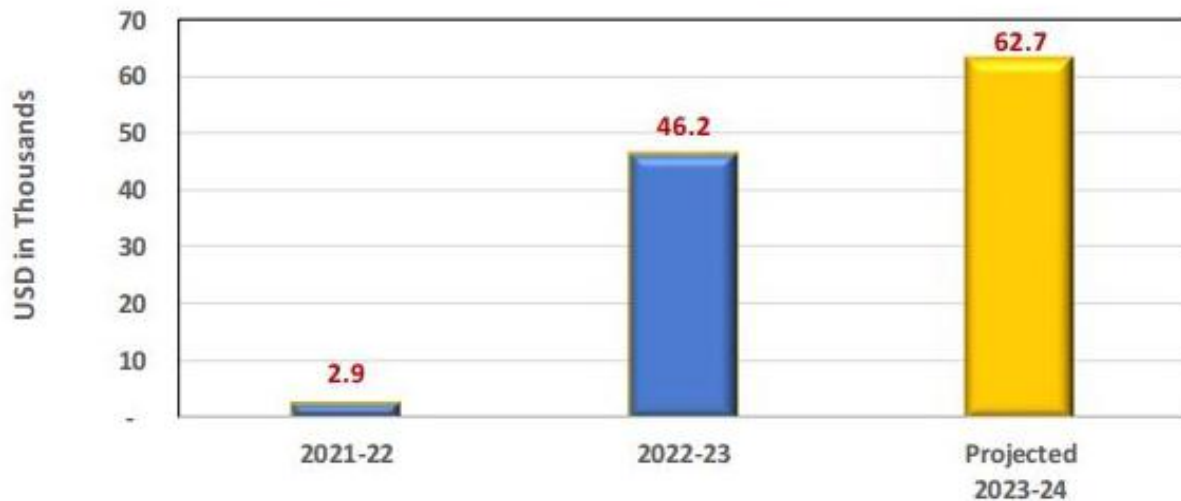
